The Decator Group, comprising the companies Decator AB with corporate identification number 556363-7379, Decator Media AB, 556419-0709 and Decator Translation AB, 556802-2122, is responsible for processing your personal data. The Decator Group or "we" care about and prioritise your privacy.

In this privacy policy we seek to inform you about how we process your personal data and about your rights.

PURPOSE AND LEGAL BASIS FOR PROCESSING YOUR PERSONAL DATA

We process your personal data for the purpose of sending you information about the Decator Group's services (technical information and translations) and to follow up on your interest in our services. We also process your personal data when you become a customer in order to administer our work such as quotations and invoices.

WHO HAS ACCESS TO YOUR PERSONAL DATA?

Your personal data is only processed by us at Decator.

WHAT RIGHTS TO YOU HAVE TO INFLUENCE HOW WE PROCESS YOUR PERSONAL DATA?

You have certain rights with regard to the processing of your personal data; see below. You are welcome to contact us (see contact details above) to exercise your rights.

Right to withdraw your consent and to object to processing

You can, at any time, withdraw all or part of the consent given, with effect from the time of withdrawal.

You have the right to object to your personal data being processed for marketing purposes, i.e. you can say "no" to our newsletter. We will then stop processing your data.

Right of access

You have the right to obtain confirmation of whether personal data relating to you is processed by us as well as access to information about how the personal data is processed, for example the purposes of the processing and the categories of personal data concerned. You also have the right to receive a copy of the personal data processed by us.

You make a request by contacting us (see contact details above).

Right to rectification

You have the right, without undue delay, to have inaccurate personal data corrected and, by providing information, to supplement incomplete personal data.

Right to erasure and limitation

You have the right, at any time, to request erasure of your personal data or that some processing of your personal data be limited.

Right to lodge a complaint

You have the right to lodge a complaint with a competent supervisory authority. Such a complaint should ideally be lodged with the authority in the member state in the EU/EEA in which you have your normal place of habitual residence, where you work or where an infringement of the applicable data protection legislation and rules is alleged to have occurred. The competent supervisory authority in Sweden is the Swedish Data Protection Authority (Datainspektionen).

Right to data portability

You have the right to receive the personal data concerning you that you have provided to us in a structured, commonly used and machine-readable format and have the right to transmit this to another data controller (data portability). You have the right to have personal data transmitted directly from us to another data controller where this is technically possible.
